COMMUNICATIONS FROM THE BOARD: Trustee Tholotowsky wanted to thank our citizens for keeping the wreath red this holiday season. He thanked the staff and everyone who was involved in the retirement party for Patti Myren. It was a wonderful ceremony, and he wishes her all the best in her retirement. He asks that after a snowfall to please keep the fire hydrants clear for the Fire Firefighter.

ATTORNEY REPORT: Attorney Motylinski updated the board that the Paid Leave for All Workers Act has entered the veto session. If passed it would remove us from the definition of Employer. He will keep us updated. The Supreme Court will be providing its final decision on 1-19-24, regarding the Pension Consolidation program.

CHIEF'S REPORT: Deputy chief Peksa told the Board that 2023 was a very successful year for training. Personnel logged in over 21,000 hours of training. We started a training committee that has 6 members, and they meet every month. He informed the Board that we responded to 387 calls in December. We ended the year with a 5.5% increase from last year with a record high of \$4,323 calls for service.

Deputy Chief Truffa let the Board know that we just received all of our Zoll monitors that we leased and hopefully they will be in service in February. He updated the Board that the ambulance we ordered two years ago should be coming in in April. Adopt a Firefighter program begins in January and runs through May.

Deputy Chief Truffa Would like to congratulate DC Truffa, FF's Hanson, Theres, Baetz, Krapil, Hanlon, Staska, Hipke, Kastner, and IT Director Fernando Alfonso. He congratulated Woodridge Police Chief Brian Cunningham on his retirement after 39 years of service. Thank you to Illinois American Water for awarding us \$1,000.00 for the 2024 Firefighter grant program. The Facilitating team had their first meeting on 1/9/24 with 20 people attending. We are working with Creative Entourage on the next steps for our community outreach program. Chief Tasso gave a special shout out to Matt, John, Carla, and Lisa for all their hard work with the final transition to Government Accounting, Inc. and Strongpay.
