

**LEMONT FIRE PROTECTION DISTRICT
MINUTES OF OCTOBER 16, 2025
REGULAR MEETING OF THE BOARD OF TRUSTEES**

CALL TO ORDER: Trustee Joseph Falese called the regular meeting of the Board of Trustees of the Lemont Fire Protection District to order on October 16, 2025, at 5:30 PM. The meeting was held at 15900 New Avenue, Lemont, IL.

Trustee Falese led the Pledge of Allegiance.

ROLL CALL: On roll call, Trustees Dan Tholotowsky, Michael Smollen, Joseph Falese, Raymond Negrete, and Linda Bernacchi were present

OTHERS PRESENT: Fire Chief Dan Tasso, Deputy Chief Matt Peksa, Deputy Chief John Truffa, Attorney John Motylinski, Recording Secretary Sandy Dominik, FGM Representatives; Jake McLaughlin, Shaun Patel, Jason Estes, and Albert Pala

FGM STATION DESIGN PRESENTATION: Jake McLaughlin gave a power point presentation of station designs with an overview of the proposed design and layout for the new fire stations. The presentation included site plans, and conceptual renderings illustrating the overall aesthetic and functional goals of the project.

TREASURER'S REPORT: Trustee Negrete read the bill list totaling \$1,170,443.82. Trustee Bernacchi made a motion to approve the Treasurer's report, as presented, seconded by Trustee Tholotowsky. FINANCIAL REPORT: Chief Tasso presented a financial report that included revenues, expenditures and current budget status. Key items noted included ongoing operational expenses, equipment maintenance costs, and progress on capital projects such as facility improvements and apparatus purchases. COMMUNICATIONS FROM THE BOARD: Trustee Tholotowsky expressed his appreciation to the Chief Administration for preparing tonight's presentation and is very impressed and proud of everyone's hard work. He remarked that Open House was a success and reminded everyone to be safe while Trick or Treating and watch out for children. Trustee Smollen stated at the next village board meeting, 10/27/25, Lemont will be honoring long time resident and advocate Barbara Bushman.

ATTORNEY REPORT: Attorney Motylinski reminded the Board, the November 20th meeting will be the budget workshop, 6:00 PM and budget hearing will be in December. He recommended the budget workshop, and hearing be moved up earlier next year. Attorney Motylinski reported to the Board that the Legislature is in Veto session and doesn't expect much to impact operations and will update the Board as needed.

CHIEF'S REPORT: Deputy Chief Peksa informed the Board the new engine has been delivered, and it will be going in for graphics and radios soon. He thanked the engine committee that consisted of; Lt. Palcu, FF Rauch, FF Hopkins, FF Kastner, Lt. Anderson, and BC Moses. DC Peksa stated Lt. Elshareif will be acquiring a second K9 for cadaver search. EVT Stacy Devitt has completed his level one certification in ambulances and will now start working on his level two certifications for ambulances and fire apparatus. They have started purchasing mechanic tools and shop equipment in preparations for the new station workspace. DC Peksa reported the District responded to 358 calls in September and still tracking a 3% decrease from last year.

Deputy Chief Truffa informed the Board that IT Director Fernando has begun to connect with vendors for station alerting, security cameras and A/V equipment regarding the new stations. DC Truffa shared that EMS Director Tyler Yost will be attending and speaking as a presenter at EMS World Expo this year in Indianapolis. Director Yost was awarded this opportunity at last year's conference. DC Truffa informed the Board ambulance billing will be affected by the government shut down, Medicare is halting submission of our payments during shutdown. DC Truffa thanked Black shift, fire prevention staff and those that came to help host another successful open house.

Chief Tasso would like to recognize work anniversaries this month; LT Flood (26), LT. Stasiak(22), FFs Hines (22), LT Elshareif, FF's Rauch, Jager, and Decamp (17), LT. Stefanelli (15), Orszulak (5), and Bacho ((2). Chief Tasso informed the board that the preliminary Battalion Chief and Lieutenant promotional process has been completed, and a preliminary list is established. The Board of Commissioners will meet on October 31st to approve the final list which will go live on November 8th. Chief Tasso informed the board there is now a signed contract to purchase the property of 15723 W. 127th and is scheduled to close on October 30th. FGM is working with the Village of Lemont on the Planned Unit Development Submission and will present to the Lemont planning commission at their December meeting. Chief Tasso reminded the Board that November meeting was rescheduled to November 20th, Mr. James Howard will be here to review the budget, levy and financials for the upcoming year.
