CHIEF'S REPORT: Deputy Chief Nickleski updated the Board on apparatus, training and the various meetings he attended since last meeting. He stated we responded to 362 calls in August which is a 17% increase over August, 2017. Deputy Chief Nickleski stated that employees logged in 1480 hours of training for the month of August. He stated RTF training continues their sessions with the Department of Homeland Security and the Lemont PD on rescue task force operations. He commented that the first level of our Budget process has been completed. The ambulance specs have gone out to bid and the committee will have a presentation for the Trustees at the Board workshop on October 11th.

Chief Rimbo stated once again we will wear our yellow childhood cancer shirts during the month of September in honor of FF/PM Chris Ganz's daughter who lost her battle to childhood cancer several years ago. He reminded the Board of the special workshop on October 11th at 5:30 to go over the proposed 2019 Budget and the presentation from the ambulance committee. He invited everyone to join us at our annual open house this year on October 13th from 11:00 to 2:00 PM. He requested permission from the Board to look into a collection agency service to help with collections against non-residents of the District. By mutual consent, the Board agreed. Chief invited Battalion Chief Frank Jareczek to present an update on our accreditation process.

BC Jareczek gave a brief update on how the process is progressing since we have officially applied as registered agency in 2018. We have three years in which to apply as an applicant agency or ask for an extension. After that we have eighteen months to get everything to the Accrediation Board who will then send a peer review board out to analyze everything that has been done. If everything is in order you will then go before the Accrediation Commission for review and approval.
