CHIEF'S REPORT: Deputy Chief Truffa stated he should have a proposal for the station alerting system by the September Board meeting. He stated our Facilities and Equipment Manager, Terry Stark, is doing exceptional and thorough work. He stated our EMS Coordinator, Tyler Yost continues to update the monthly EMS training. The trainings have been well received by the shift personnel.

Deputy Chief Peksa updated the Board on apparatus, training and the various meetings he attended since last meeting. He stated we responded to 325 calls in July which is an increase of 15% over July, 2020. He stated our hydrant inspections are completed and thanked all the members and Lt. Fischer who was in charge of the program. He stated we began to clean up our Stations and has learned a lot about record retention. He thanked Prologis for their donation of a building at 1205 Davey Road for training purposes.

Chief Jareczek updated the Board on the current state of the District during Covid-19 pandemic. Chief Jareczek stated we were well received at the Emergency Vehicle night car show. He stated we will be holding a short memorial service at 8:30 AM on September 11<sup>th</sup> at Station 1 in honor of the 20<sup>th</sup> anniversary of that fateful day. He wanted to invite all to attend the service.
