CHIEF'S REPORT: Deputy Chief Truffa stated the Station Alerting project will begin on December 20th. We will begin the weekly Covid testing for the employees who are unvaccinated.

Deputy Chief Peksa updated the Board on apparatus, training and the various meetings he attended since last meeting. He stated we responded to 334 calls in November which is an increase of 5% over November, 2020. He stated that we will be participating in cross training with Citgo Fire in 2022.

Chief Jareczek updated the Board on the current state of the District during Covid-19 pandemic. He stated the Deputy's and himself served the veterans at their luncheon and then the seniors at their luncheon.

LEVY HEARING: A motion was made by Trustee Negrete to open the meeting to the public at 6:21 PM for comments with regards to Ordinance 21-03, Tax Levy Tax Year 2021, seconded by Trustee Kasperski. Chief Jareczek stated we are requesting the sum of \$12,031,168.00 to be levied for the tax year 2021. Chief Jareczek stated we have met with our insurance broker's, Vista National, and the Health Insurance Committee to discuss this year's renewal. It is the Health Insurance Committee's recommendation to approve the following coverage: remain with Blue Cross Blue Shield at a 16.75 % increase; change dental carrier to Guardian at a 5% decrease; remain with vision carrier, Eyemed, with no increase for (2) years; remain with life insurance carrier, Standard, at a 0% increase; remain with the District funding of the H.S.A. to \$2000/\$4000; and continue the health insurance opt-out program. The above recommendation is an overall 15.99% increase to our insurance cost. A motion was made by Trustee Kasperski to approve the health insurance renewal options, as recommended by the Insurance Committee, seconded by Trustee Negrete. Roll Call: Trustee Cobbett, yes. A motion was made by Trustee Negrete to approve the engagement letter from Karrison LLC to perform the audit for fiscal year ending December 31, 2021 at a cost of \$12,600.00, seconded by Trustee Tasso.
