LEMONT FIRE PROTECTION DISTRICT MINUTES OF MAY 19, 2022 REGULAR MEETING OF THE BOARD OF TRUSTEES

CALL TO ORDER: Trustee Victoria Cobbett called the regular meeting of the Board of Trustees of the Lemont Fire Protection District to order on May 19, 2022, at 6:01 PM. The meeting was conducted at 15900 New Avenue, Lemont, IL.

Trustee Cobbett led the Pledge of Allegiance.

TREASURER'S REPORT: Trustee Tasso read the bill listing totaling \$796,078.76. Trustee Tasso made a motion to approve the Treasurer's report, as presented, seconded by Trustee Negrete. COMMINICATIONS FROM THE BOARD: Trustee Tasso informed the Board at the Pension Fund board meeting last night they received a draft update on the actuarial report. He stated it shows the fund is 86.19% funded and the levy request has decreased by 16.62% over last year's request. Trustee Cobbett informed everyone that on May 30th at 11:00 AM the VFW will be holding a Memorial Day Service at the WWII Memorial.

ATTORNEY REPORT: Attorney Gilbert stated no decisions have been made on the current Pension Fund case in Kane, County stating a ruling is supposed to come out tomorrow. He informed the Trustees on new legislation for property annexed by a Municipality, if a lawsuit is filed because they do not pay the reparations required by law they are responsible for Attorney fees.

CHIEF'S REPORT: Deputy Chief Truffa stated the Station Alerting project is still not complete, he is hoping for completion very soon. He stated EMS Coordinator Yost taught a trauma class for paramedic students at Silver Cross. He stated Fire Marshal Jen Murray is doing well in her new role and is highly motivated and has a lot of ideas for Public Education.

Deputy Chief Peksa updated the Board on apparatus, training and the various meetings he attended since last meeting. He stated we responded to 297 calls in April which is an increase of 6.07% over April, 2021. He thanked Prologis for the donation of the building at 2501 Davey Road, he stated we logged in over 687 hours of training. He stated the Engine committee is hoping to come to the Board in June with a presentation.

Chief Jareczek updated the Board on the current state of the District during Covid-19 pandemic. He stated our weekly rapid testing is going well, we have not had any positive results to date. He acknowledged that the District received the certificate of achievement for excellence in financial reporting for the third year in a row. He thanked Executive Assistant Clark for her hard work on completing and submitting the report. He stated we have received over \$15,000.00 the first quarter from Fire Recovery. He informed the Board the family of U.S. Army Staff Sergeant Gerald R. Helms were very appreciative with our participation with the Illinois Patriot Guard in the escort home of his remains.
