## LEMONT FIRE PROTECTION DISTRICT MINUTES OF JANUARY 19, 2023 REGULAR MEETING OF THE BOARD OF TRUSTEES

CALL TO ORDER: Trustee Victoria Cobbett called the regular meeting of the Board of Trustees of the Lemont Fire Protection District to order on January 19, 2023, at 6:00 PM. The meeting was conducted at 15900 New Avenue, Lemont, IL.

Trustee Cobbett led the Pledge of Allegiance.

TREASURER'S REPORT: Trustee Negrete read the bill listing totaling \$1,270,596.15. Trustee Negrete made a motion to approve the Treasurer's report, as presented, seconded by Falese. Roll Call: Trustee Cobbett, yes. Trustee Negrete, yes. Trustee Bernacchi, yes. Trustee Tholotowsky, yes. Trustee Falese, yes. Motion carried.

COMMINICATIONS FROM THE BOARD: Trustee Tholotowsky informed the Board that as of 1/1/23 Illinois Smoke Detector Act is now in place regarding the 10 year battery requirement in new residential homes. He stated that the Governor has proclaimed this week as Illinois Community Risk Reduction week. Trustee Tholotowsky would like to pass on condolences to the family of James Cainkar, who passed away in December. He was an engineer for the Village of Lemont and many municipalities. Also worked for The Lemont Fire District in the past.

ATTORNEY REPORT: Attorney Motylinski stated the 2023 levy CPI is 6.5%. This exceeds the amount allow by PTELL and we will need to hold a Truth & Taxation hearing at the end of the year. The Ill Supreme Court has stayed the cash bail component of the Safety Act.

CHIEF'S REPORT: Deputy Chief Truffa spoke today with Deputy Chief Peksa who is in Minnesota for a pre-construction meeting for a new engine. Chief Peksa said that the pre-construction meeting went very well. Our new Tender has arrived and is in the bay at Station 1. The total calls for December was 395 which was up 5% since December of 2021. We had 4097 calls for the entire year which is the highest since we have been tracking. Deputy Chief Truffa updated the Board that we have collected \$50,480.00 from Fire recovery for 2022 with 91 calls and we collected \$37,621.00 in 2021 with 65 calls. Fire Prevention Bureau completed 99% of all inspections for 2022 and will finish them up this month. The Village of Woodridge is updating their building codes to 2021. Fire Marshall Murray had a meeting with

the Village of Lemont about updating their codes from 2015 to 2021. That way everyone in our District will have the same building codes. Public Education worked with Tractor & Toys and Toy Express this year. It went very well and it was nice to see so many come in and pick out Christmas presents. We began our Adopt a Firefighter program. We have 12 members including Chief Tasso.

Chief Tasso stated that he has been able to visit every station and meet with all the Administration and Lieutenants. Chief Tasso has met with Will County Fire Chief's Association, the Village of Woodridge Administration, Lisle-Woodridge Fire Department and Darien-Woodridge Fire Protection District Fire Chief's. He will continue to meet with other sounding fire stations.

Chief Tasso informed the Board Lisa Gabor was recognized for her 5 years of membership with IFSAP at the IFSAP Awards Luncheon on 12/9/22.
