LEMONT FIRE PROTECTION DISTRICT MINUTES OF FEBRUARY 16, 2023 REGULAR MEETING OF THE BOARD OF TRUSTEES

CALL TO ORDER: Trustee Victoria Cobbett called the regular meeting of the Board of Trustees of the Lemont Fire Protection District to order on February 16, 2023, at 6:00 PM. The meeting was conducted at 15900 New Avenue, Lemont, IL.

ATTORNEY REPORT: Attorney Lamb informed the Board that Atty John Motylinski will be in contact to inform us who will be the public member on the Decennial Committee. The pension fund litigation was in favor of the larger funds. The next step would be to take it to the Illinois Supreme Court.

CHIEF'S REPORT: Deputy Chief Peksa updated the Board that the land purchase contracts have been signed and we are waiting for the environmental study and soil stability testing. Rebound Vitality came to the stations to assess our FF/Paramedics. They use sensors to find possible weaknesses in the knees, hips, back etc. Then they are given exercises that can prevent up to 60% of injuries. Deputy Chief Peksa informed the Board that the new Tender has been delivered and the goal is to have it in service by the end of March.

Fire Chief Tasso informed the Board that the Strategic Plan has been completed and published on the website. The Deputy Chief's are working on updating the Standards of Cover document that is 2 years old. Chief Tasso informed the Board that Senate Bill 1306 was filed on February 3rd and would amend the EMS Systems Act requiring all EMS personnel to be equipped with body cameras. He will update the Trustees as he receives any information.

OLD BUSINESS:

NEW BUSINESS: The Chief informed the Board that in order to keep a quorum, he will be stepping down from the Pension Board after they hold their elections. He will recuse himself from any vote that could possibly be a conflict of interest.

We received approximately 20 applications and did interview 3 candidates this week. Fire Chief Tasso thanked Mike Smollen for all his help with the interviews for the new mechanic.
