LEMONT FIRE PROTECTION DISTRICT MINUTES OF APRIL 20, 2023 REGULAR MEETING OF THE BOARD OF TRUSTEES

CALL TO ORDER: Trustee Victoria Cobbett called the regular meeting of the Board of Trustees of the Lemont Fire Protection District to order on April 20, 2023, at 6:00 PM. The meeting was conducted at 15900 New Avenue, Lemont, IL.

SWEARING IN CEREMONY: Trustee Cobbett administered the oath of office of Firefighter/Paramedic to Brandon Davis. Congratulations were given by all.

RECESS: Trustee Cobbett called for a 15-minute recess at 6:08 PM and invited all to enjoy some refreshments.

RETURN TO REGULAR MEETING: The regular meeting reconvened at 6:23 PM.

TREASURER'S REPORT: Trustee Tholotowsky read the bill listing totaling \$998,838.60. Trustee Tholotowsky made a motion to approve the Treasurer's report, as presented, seconded by Trustee Bernacchi. Roll Call: Trustee Cobbett, yes. Trustee Falese, yes. Trustee Bernacchi, yes. Trustee Tholotowsky, yes. Motion carried. Absent from the vote; Trustee Negrete.

James Howard presented to the Board a power point presentation and financial report with the year-to-date expenses and revenues through March 31, 2023.

COMMUNICATIONS FROM THE BOARD: Trustee Tholotowsky would like to give his condolences to the Chicago Fire Department on the loss of two members. Trustee Tholotowsky congratulated Firefighter Brandon Davis for completing his probationary training.

ATTORNEY REPORT: Attorney Motylinski reminded the Board that next month they will have to have a committee put together for the Efficiency Act. He will provide an ordinance for us at the May Board meeting. He informed the Board HB1625 has passed and eliminates the MMAI appraisal from the process of selling real estate. He updated the Board that HB1626 increases the bidding threshold from \$20,000.00 to \$30,000.00. This was due to the price increase on most goods and services. He let the Board know that there will be a change to the Open Meetings Act allowing the Board to hold an entirely remote meeting. If the meeting is remote, the agenda posted should reflect that it will be a remote meeting.

CHIEF'S REPORT: Deputy Chief Truffa informed the Board that we have updated the firewall system which makes our network more secure. He let the Board know that our EMS coordinator Tyler Yost attended an advanced cardiac class hosted by Zoll. It was open to all EMS Coordinators in the Silver Cross system. They are looking at new ways of doing cardiac resuscitation based on different studies. He updated that Board that there is an increase in residential sprinkler systems being put in. Summer Olympics will be finishing in May and Adopt a Firefighter will continue until the end of the school year.

Deputy Chief Peksa informed the Board that the radio and graphics have been installed on the new tender and it should be in service by the end of the month. Trustee Tholotowsky asked what we will do with the old tender. DC Peksa stated that we will sell it. He updated the Board that the new hires are on their second rotation and each rotation is 4 months of training and evaluations. Deputy Chief Peksa informed the Board that he is working with the IPRF representative regarding their HELP program which will help keep our workman's comp rates down. He let the board know that our new Emergency Vehicle Technician, Stacy Devitt, has started working and is settling in well.

Fire Chief Tasso would like to congratulate Lt Steve Frank and Lt Bill Anderson on their 21 years of service with us. He informed the Board that Phase I ESA has been completed and now we need to proceed with the Phase II ESA on the 127th Street properties.
