CHIEF'S REPORT: Deputy Chief Peksa updated the Board on our new probationary FF Kevin Atwood who will be starting to work shifts on 10/18/23 and said he is doing well. We finally received our build slot for a new engine in March of 2024. Hopefully we will take delivery end of 2024 or beginning of 2025. The Training Committee is working on putting together the 2024 Training Calendar. We went on 382 calls in September which is an 8% increase over last year.

Deputy Chief Truffa informed the Board that Steven Bacho, our new Facility Manager, started on 10/17/23. Fire Marshal Murray has completed all the school inspections for this year. FLSA Sandy Dominik attended the Trick or Treat Trail at the Park District and will attend the Halloween Hoedown on 10/28/23. The Engines will be out around town on Halloween giving out candy. This is very well received in the community and the FF's love doing it.

Chief Tasso would like to recognize BC Evers, LT's Stasiak, Flood, and Elshareif, FF's Hines, Stefanelli, Orszulak, DeCamp, Rauch, and Jager on their work anniversaries this month. Chief Tasso shared with the Board thank you letters that we received. He would like to thank everyone who came to our Open House on 9/30/23, making it a huge success. He thanked the community partners who assisted us with Open House. The message for this year's Fire Prevention Month is Cooking Safety Starts With You. According to the NFPA 50% of all home fires involve cooking equipment. Chief Tasso informed the Board that he received Carla Clark's letter of resignation, and she will be retiring on 10/27/23. Thank you for over 22 years of dedicated service to the Fire District. He reminded the Board that next month the regular meeting will be on 11/9/23 at 6pm and the budget workshop will be right before it at 5pm.
