LEMONT FIRE PROTECTION DISTRICT MINUTES OF NOVEMBER 09, 2023 REGULAR MEETING OF THE BOARD OF TRUSTEES

CALL TO ORDER: Trustee Joseph Falese called the regular meeting of the Board of Trustees of the Lemont Fire Protection District to order on November 9, 2023, at 6:00 PM. The meeting was conducted at 15900 New Avenue, Lemont, IL.

James Howard presented to the Board a power point presentation and financial report with the year-to-date expenses and revenues through 10/31/23.

COMMINICATIONS FROM THE BOARD: Trustee Tholotowsky wanted to remind people that "cooking safety starts with you" and to practice fire safety while cooking. Remember to change your batteries in your fire detectors or replace them with new 10-year smoke detectors. Veterans Day is coming up and Trustee Tholotowsky would like to thank all Veterans including those that work here.

ATTORNEY REPORT: None

CHIEF'S REPORT: Deputy Chief Matt Peksa informed the Board that we have received grant money in the amount of \$2,300 from OneOk, \$2,000 form Exxon Mobile, and \$1,000 from Illinois American Water. The majority of that money will go towards Mass Casualty Kits to put on the ambulances. We responded to 384 calls in the month of October. This is an increase over last year's 335 calls.

Deputy Chief Truffa attended a meeting with Will County Emergency Management and is trying to get a Port-Security Grant pushed through to have a boat launch in our area rescues. We have an April delivery for our new 2024 ambulance chassis. He let the board know that the new Facility Manager Steve Bacho is doing very well. Effective November 13th the Village of Woodridge adopted the 2021 Fire

Code. The on-duty personnel handed out candy in the neighborhoods throughout Lemont during Trick or Treating. The Firefighters enjoy this as much as the kids do.

Fire Chief Tasso would like to recognize DC Peksa and FF Craig Newmes on their work anniversaries this month. FF's Gordon, Ingram, and Romo-Martinez have completed their probation and will be sworn in at the December Trustee meeting. Chief Tasso shared with the Board the thank you letters that we received. WE currently have 17 community members that have expressed interest in joining our facilitating team and we hope to have our first meeting in December. The staff will be going to the Lemont Park District to serve lunch to the Veteran's at the Core. On Saturday will be participating in the VFW Veteran's Day service.
