Deputy Chief Truffa updated the Board about our transition to Government Accounting, our new accounting firm. It is going very well, and we have started training on QuickBooks. The annual fire inspections are 98% complete and will be completed by the end of the year. The Village of Lemont has adopted 2021 Codes and will be effective on 1/1/24. Some of our personnel along with Finnley Forever Foundation and Lights & Ladder Brigade, decorated the house of one of our Fire Buddies with Christmas lights. We will be collecting toys for the Toy Express Children's Charity until 1-4-24. We have been very active in the community this holiday season serving lunch at the Senior Luncheon and participating in the Toy drive.

Fire Chief Tasso would like to recognize Battalion Chief Bettenhausen, Lt Fischer, Lt Palcu, FF Kingman, and FF Armor on their work anniversaries this month. Our first Facilitating Team meeting will be on 1-9-24. At this time, we have 21 people interested in joining the team and hopefully we will have a few more sign up. Chief Tasso requested direction from the Board to secure 2023 pricing before the 2024 price increase, for a new ambulance. The Board was all in favor of the Chief securing the 2023 cost of a new ambulance. Chief Tasso requested direction from the Board to purchase new decontamination solutions for the HazMat vehicle, before the end of the year, to prevent unnecessary cost increase. The Board was all in favor of the Chief purchasing new decontamination solutions to prevent incurring unnecessary costs.
